Medical Record (Important)

The College of Physicians and Surgeons of Ontario mandates that all clinical records of patients be kept by the physician or a fully compliant medical records facility for a specified period. I have contracted with **RSRS (Record Storage & Retrieval Services)**, a physician managed storage company, to store the records for this practice and to transfer a copy upon your instruction.

I strongly recommend that you obtain a copy of your personal medical history from RSRS.

The information in your chart is important for your continued care and may not be available to you or your next healthcare provider otherwise. Please insure any specialist, labs, X-Ray facilities know the name and address of your new healthcare provider. **As of December 14th 2017, I am no longer responsible for any of your test results.**
